Topic: 2025-26 Income Tax Updates: The One Big Beautiful Bill introduced some tax changes for 2025 and 2026. One important tax break for seniors is the \$6000 deduction per person over 65. It functions like the personal exemption and phase out begins at \$75,000 for single filers and \$150,000 for joint filers. A deduction for car loan interest is back and filers do not have to itemize deductions. It is available until 2028 but there are restrictions for qualifications. There will be a deduction for Tip Income up to \$25,000 and filers do not have to itemize. Restrictions and phase outs will apply. There will be a deduction for Overtime Pay up to \$12,500/\$25,000 with restrictions and phase outs. Student Loan Interest up to \$2500 is deductible with phase outs.

2026 has a Charitable Contribution deduction up to \$1000/\$2000 for non itemizers and an Educator Expense will have an itemized deduction with no dollar limit and no phase out. Mortgage Ins Premiums will be back on the 2026 itemizing with restrictions. Many of the tax credits are still available such as Child Tax Credit, Earned Income Credit, Dependent Care Credit, Premium Tax Credit, American Opportunity Credit and more in 2025.
