Paul Loughran, President Elect volunteered.

Kiwanis International has its own official Bylaws that govern the organization and provide the basis for the Standard Form for Club Bylaws that local Kiwanis clubs must adopt and follow. The International Bylaws define the principles, structure, and governance of Kiwanis International, including details on voting, officer roles, and member conduct. The official document, such as the one effective October 2023, can be found on the <u>Kiwanis</u> International website.
